# **TEACHING ART, ALL GRADES** (MA)

#### **Program Description**

Coursework in MA program in Teaching Art, All Grades (https:// steinhardt.nyu.edu/degree/ma-teaching-art-grades-k-12-initialcertification/) is designed for students who wish to pursue graduate-level professional training leading to an initial certification as artist-teachers in primarily public and private schools both nationally and internationally. The program combines a strong foundation in contemporary art with a solid grounding in education for social justice and practical teaching experience.

Through a sequence of core courses grounded in a progressive social justice approach, students examine the making and teaching of art as a social and political act, and consider its philosophical, historical, political, and sociological contexts. We foreground a commitment to anti-racism and culturally sustaining pedagogy as a throughline in all of our coursework. Students develop their teaching philosophy and practical skills through courses in education, art education, and research methodologies while continuing their work as artists fulfilling creative course assignments and a graduate-level studio course.

For students who have an undergraduate BA or BFA degree in studio art and wish to acquire teacher certification, the MA Program in Teaching Art, All Grades, offers a curriculum that satisfies the academic requirements for New York State teacher certification.

## Fieldwork

Graduate students in the Teaching Art, Grades K-12, Initial Certification program participate in two types of fieldwork: serving as a Learning Partner and as a Student Teacher. All fieldwork experiences are selected, supervised, and supported by NYU faculty in collaboration with the Office of School and Community Partnerships (https://steinhardt.nyu.edu/ about/teacher-education/field-initiatives-and-partnership-schools/).

An additional Art+Education fieldwork experience includes participation in the Visionary Studio: Saturday Workshop program (https:// steinhardt.nyu.edu/programs/art-education/high-school-programs/ visionary-studio-saturday-art-workshop/). MA Art+Ed students design a thematic, multimedia curriculum for high school students and then coteach classes that address current social issues and questions and the ways in which art and artists influence society.

#### **Career Opportunities**

Our students go on to teach in public, private, and independent PreK-12 schools in the US as well as internationally, with a significant number joining the New York City Department of Education as Visual Art Teachers. Some choose to teach in museum education or not-for-profit and community-based organizations as well as serve other educational roles such as curriculum consultants and on curatorial projects. Some graduates eventually pursue further study in PhD or EdD programs.

## Accreditation (AAQEP)

The New York University Teacher Education Program, which is designed to prepare students to meet the challenges of teaching and leadership in today's demanding educational environment, is granted accreditation by the Association for Advancing Quality Educator Programs (AAQEP) for a period of seven years, from April 2020 to June 2027. - Implement discipline-based curricula, lesson, and unit plans that use experiential learning and culturally relevant pedagogies to support critical thinking, creative inquiry, and social change inspired by contemporary approaches to art making & analysis.
- 4. Facilitate clear, creative, and innovative teaching strategies that are student-centered, appropriate to a specific sociopolitical and historical context, and effectively use technology to support student learning.

- 5. Demonstrate the ability to be reflective practitioners and effective researchers who understand how to integrate theory/research with pedagogical and classroom practice.
- 6. Build relationships with students and families to foster student learning, engagement, and well-being and serve as persuasive cultural advocates and community leaders able to articulate the importance of art in schools, institutions, and society at large.
